



Defense of KKK: Foolish vs. admirable

Anthony P. Griffin laid out a seemingly reasoned argument for his decision as a black lawyer to represent the Ku Klux Klan in its efforts to block court-ordered disclosure of its membership lists ("Defending the Klan," Opinion USA, Wednesday). I, too, am a black lawyer, but one not naive enough to compare the KKK with the NAACP. The Klan is a terrorist organization whose foremost historic mission remains the same; the absolute





The American Civil Liberties Union is defending the Texas Klan's right to not divulge information about themselves, and the ACLU lawyer chosen to do the pro bono work is Anthony Griffin. Griffin is also the chief counsel for the Texas NAACP, and an African American. He joins us now on the telephone.

Mr. Griffin, your boss at the ACLU essentially assigned this case to you. Did you ever consider turning it down?


